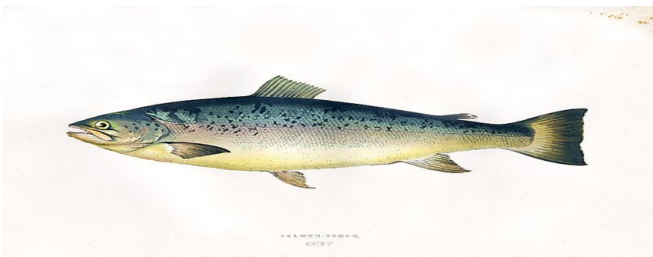

2014 Small Boat Big Fish – Huge Success

Saturday, August 2nd, 2014, saw the sun rise on a beautiful, calm day, out of Manistee County, on Lake Michigan. Sixteen boats each carried at least one avid MCSFA member with great hopes of landing the “BIG ONE.”

The “Small Boat/Big Fish” Tournament only takes one fish to win, so everybody has a good chance. Just at daybreak, as soon as you could get the lines in, already some boats were landing fish. Glow plugs and glow spoons were going off.

About 11:00 AM a dense fog enveloped much of the fishing fleet, but everyone kept a sharp eye and by 12:30 PM the fog was gone. Boats arrived back at the docks in Arcadia, Onkama and Manistee with anywhere from 2 to 7 fish.

First place went to “Reel Thing” from Onkama. Mike Mastrianni and crew landed a 19.05# king that won the \$500.00. Second place was 18.8# fish, third place 17.05#, fourth place 15.05# and fifth place 14.3#.

The “Small Boat/Big Fish” tournament is designed and intended for amateur fishermen and fisherwomen only. Next year, August 1st, 2015, the tournament will continue with anyone meeting the criteria of the boat under 25 feet and at least one MCSFA member aboard, you are welcome to enter.
